Agreed Order to Dismiss

Now comes the Plaintiff, Dale Kirchner, by counsel, Lawrence M. Schultz, and the Defendants, Brett W. McMillion, Director of the West Virginia Division of Natural Resources, and the West Virginia Division of Natural Resources, by counsel, Katie Franklin, Assistant Attorney General, and do jointly **move** this Court to dismiss this case from the docket.

In support of this motion, counsel for the Defendants sets forth as follows: The Defendants maintain that the West Virginia Division of Natural Resources has provided lawful notice, pursuant to §§ 20-5-16 and 59-3-2 of the West Virginia Code, and would prevail on the merits. However, the Defendants do not wish to proceed if there is an *appearance* of impropriety, but instead desire to assure the public that it is in full compliance with any and all notice requirements. Accordingly, the Defendants find it fitting to cancel the meeting scheduled for April 18, 2023. Any future public meeting will be noticed in such a way as to alleviate the concerns set forth in the *Petition for Writ of Mandamus*. As the Plaintiff is receiving his requested remedy, the Plaintiff agrees that this matter is now moot, and does not object to dismissal.

WHEREUPON, this Court does herein FIND that by canceling the public

meeting scheduled for April 18, 2023, this matter is now moot. The Court does **GRANT** the joint motion, and does **ORDER** this matter **DISMISSED** and stricken from the docket. The hearing on the rule to show cause scheduled for April 17, 2023, at 4:00 p.m. is **canceled**. Nothing in this *Agreed Order to Dismiss* prohibits the Defendants from rescheduling a new meeting at a later date.
